

Committee	Accreditation Committee
Committee Charge	Oversee the NAMSS Accreditation Center.
Committee Goals/Responsibilities	<ol style="list-style-type: none"> 1. Review and approve or decline CE accreditation applications by vendors and state affiliates. 2. Review, evaluate, and recommend to the Professional Development Council updates to accreditation application process and policies.
Committee Composition	The Accreditation Committee is comprised of: a Chair, Vice Chair, and a minimum of four (4) additional members.
Membership Term	All committee members, including the Chair, serve a one (1) year term and are eligible for reappointment for up to two additional terms (up to three years of service). Terms run January 1 st – December 31 st .
Expected Commitment	The Accreditation Committee meets at least monthly by virtual conference. All members are expected to regularly review accreditation applications via online shared files. Time commitment is 2-3 hours per month (approximate).
Selection/Appointment	The Chair and Vice Chair are appointed by the President-Elect. Committee members are selected by the President-Elect with input from the committee Chair. Committee member selections are approved by the Board.
Reporting	The Accreditation Committee reports to the Professional Development Council, providing verbal or written updates as needed.
Committee Requirements	<p>Committee Members:</p> <ol style="list-style-type: none"> 1. Express desire to serve with an interest/background in education. 2. Must be able to carry out the work of the committee. 3. Desire to advance the mission of NAMSS. 4. Active in the medical services or managed care profession. 5. Ability to work well with others. 6. Ability to make the necessary time commitment. 7. NAMSS member in good standing. 8. Ability to attend and actively participate in conference calls. 9. The Chair may identify specific needs based on committee need (i.e. MCO, CVO, Hospital representatives or members with an interest in Industry Updates, Executive Leadership, etc.). <p>Committee Chair: In addition to the qualifications listed above, the Chair must hold CPCS or CPMSM certification.</p>
